Dear Friends,

As we look back at 2017, we would like to take the opportunity to express our sincerest gratitude for all of those who helped make 2017 a great year for the Foundation. Thank you to all our members, donors, golf outing and Annual Meeting sponsors, and all the contributors to numerous other fundraising events held throughout the year. Without your generous support, this Foundation would not exist. Your gifts and charitable donations have furthered the mission of the Foundation by improving recreation and conservation throughout the Muskingum River Watershed.







2017 was another successful year of awarding grants for the Foundation. The Foundation awarded 14 grants totaling nearly \$24,000. These grants supported education and outreach, recreation, and safety and law enforcement projects. Since 2004, the Foundation has funded more than \$350,000 in grant projects throughout the Muskingum Watershed.

Our golf outing continues to be an extremely successful fundraiser! The 2017 outing - our 19th Annual event was our second-highest grossing outing. The event has truly blossomed into the area's premier golf outing. We cannot thank our sponsors and participants enough for making the 2017 outing so successful!

The Third Annual Meeting held on November 3 was another great affair, as attendees celebrated the Foundation's successes and accomplishments of 2017 while hearing from the Mini Grant recipients. Proceeds from this fundraiser will once again support the Mini Grant Program for 2018. We look forward to supporting more great projects at youth camps in the Muskingum Watershed in 2018.

Our three endowment funds continue to grow strongly; we saw a 16% growth in our investments in 2017. Our total assets grew by an impressive 17% to a year-end balance of over \$870,000. While the Foundation remains small by charitable foundation standards, it has made a significant impact. The growth of our assets and endowment funds will ensure there will be funds for many future projects for decades to come.

We have big goals for 2018. We aim to increase membership, increase fundraising, and grow our assets to \$1 million. The Foundation will also award its 100th grant in 2018. With the support of generous members and donors, we can reach these goals. With your continued support and generosity, we can further our mission and continue to make a positive impact in recreation and conservation, improving the quality of life for residents in the beautiful Muskingum Watershed!

MINI GRANT PROGRAM

2017 marked the second year of the Foundation's Mini Grant Program. The Mini Grant Program is open to the thirteen youth camps along Muskingum Watershed Conservancy District lakes and funds programs and projects supporting recreation, natural resource conservation, and outdoor and environmental education.

The Foundation conceived the idea of a Mini Grant Program in 2015 as a way to further support the programs and projects of the thirteen youth camps. The Board of Trustees decided to dedicate all proceeds from the Annual Meeting fundraiser each year to support the Mini Grant Program.

"Each year thousands of children attend the youth camps along the MWCD lakes," said Development Coordinator Nick Lautzenheiser. "The Mini Grant Program was established to help support the great work of these camps by providing additional resources to enhance the educational experience and increase recreational opportunities for these youth," added Lautzenheiser.

The 2017 Mini Grant Program funded a total of \$5,000 to four youth camps. Camp Presmont received \$750 for kayaks. Ohio FFA Camp Muskingum received \$2,000 for stand-up paddleboards. The Pleasant Hill Outdoor Camp was awarded \$1,000 for an entomological identification

project. YMCA Camp Tippecanoe was awarded \$1,250 for camping equipment. Representatives from the youth camps spoke about their projects at the Annual Meeting.

"Although these grant awards are not large, they make a significant impact," said Foundation Chair Jim Schoch. "Because of the success of the Annual Meeting and the great projects we have seen these past two years, the Board of Trustees will continue to allocate funding for the Mini Grant Program."



2017 ANNUAL MEETING

November 3, 2017 | Performing Arts Center, New Philadelphia

The Foundation held its third Annual Meeting on Friday, November 3, 2017 at the Performing Arts Center in New Philadelphia. Nearly 160 people attended the event, which included a dinner and program featuring keynote speaker Dr. Stephen Spear of The Wilds.

Dr. Spear is the Director of Wildlife Ecology at The Wilds, where he is involved with a number of conservation projects with local wildlife, such as the Eastern Hellbender, American Burying Beetle, bats, bobcats, terrestrial salamanders, and raptors.

Dr. Spear riveted the crowd with the fascinating, world-class conservation work happening right here in the Muskingum Watershed at The Wilds.

The Wilds is a facility that combines cutting-edge conservation science and education programs with unique

visitor opportunities.

The Annual Meeting also highlighted the second round of Mini Grant recipients. Representatives from Ohio FFA Camp Muskingum, the Pleasant Hill Outdoor Camp, and Camp Presmont explained how their respective projects improved the experiences of their youth campers.

"The Annual Meeting is our way to say thank you to our generous members and donors and to celebrate the accomplishments of the Foundation each year," said Development Coordinator Nick Lautzenheiser. "Because of the overwhelming support for this event, the Foundation is able to continue to support the great work of our youth camps," Lautzenheiser added.

Board of Trustees Chairman Jim Schoch thanked all of the generous event sponsors, which included DLZ, Environmental Design Group, GPD Group, McMahon DeGulis, and Omnipro Services. In addition to the event sponsors, there were a number of table and program sponsors. "We simply cannot put on an event like this without the support from our sponsors," Schoch explained.

Established in memory of former MWCD Ranger, James R. Pitney, this fund supports training and education for MWCD rangers and peace officers in Ashland and Richland counties.



2017 TOUR of the MWCD


On July 15 Nick Lautzenheiser, Foundation Development Coordinator, completed the second annual Tour of the MWCD. This fundraiser supports the Bike and Hike Fund, which was established in 2016 to support bicycle and trail infrastructure projects throughout the Muskingum Watershed, including trails in parks and communities, bike lanes and signage on roads, and trailhead amenities.

The 2017 Tour was a one-day, 239-mile bicycle ride highlighting the Muskingum River, the lower Tuscarawas River, and the Duck Creek. The route travelled through New Philadelphia, Newcomerstown, Coshocton, Dresden, Zanesville, McConnelsville, Beverly, Marietta, Caldwell, Cambridge, Port Washington, and Tuscarawas. The ride took 13 hours and 30 minutes. Nick averaged just under 18 miles per hour. He started at his home near Mineral City at 6:00 AM and finished at the MWCD Main Office in New Philadelphia at 8:45 PM.



Lautzenheiser in Marietta, near the confluence of the Ohio River and Muskingum River





The Muskingum Watershed Conservancy Foundation was officially incorporated in February 2001 as a 501(c)3 nonprofit charitable organization with the mission of providing financial resources to enhance facilities, programs, and conservation efforts on or adjacent to Conservancy District lands and waters.

There are currently 16 charitable funds within the Foundation, which support conservation, water quality, recreation, and environmental education projects throughout the Muskingum Watershed. Since 2004, the Foundation has funded 98 projects totaling nearly \$350,000.

In addition to supporting worthwhile conservation and recreation projects, the Foundation was created to help donors meet their charitable goals. The Foundation has helped a number of individuals realize dreams and honor loved ones by establishing charitable funds in their memory.
